<u>Minutes</u>

Treasurer has completed and submitted tax documents.

President received email request for mini-workshop about interpreting in Social Security settings, jargon, etc. CDHH recently provided a similar workshop, not many were aware or able to attend. Fran added this topic to list of PD topics.

North Idaho Deaf Club requested sponsorship for 2023 Deaf Fest & Comedy Show. Past events like this have not benefited IdahoRID. Board agreed to sponsor \$100. See ACTION ITEM below.

ACTION ITEM – <u>Treasurer</u> to send cheque for \$100 to North Idaho Deaf Club by 03/06 AND \$200 to ASLTA Spring Workshop by 03/06

ASLTA Spring Workshop (March 10-11) requested donation. They sponsored our mini-workshop (\$200) in 2021 and Board agreed to do in-kind donation of \$200 for this event. See ACTION ITEM above.

Workshop updates -

February CEUs will be submitted this week.

Jen Harvey will present a mini-workshop in May 2023.

Spring Workshop - presenter rate has increased, looking at approx. \$3800 for presenter alone. Will this be profitable given the 50th Celebration in October? Discussion on downsizing the Sping Workshop to a smaller half-day training with Business Meeting (in-person). See ACTION ITEMS below.

ACTION ITEM – <u>**PD Chairs**</u> to explore spring workshop ideas and email Board in the next week AND reach out to Orlando for September mini-workshop on trilingual interpreting.

Bylaw voting during spring workshop.

Discussion regarding D/deaf community members understanding items on election/voting ballots. CDIs should be used and everything must be signed/interpreted neutrally. This is a big undertaking for IdahoRID alone, should be partnered with other organizations (ACLU; voter's rights group...), interpreters should be paid. Is this considered political affiliation? Have other states done this? Who pays for filming, etc.? Dawn and/or Fran to get more details on what exactly is being requested.
