Minutes

RID Restructuring

- RID is asking IdahoRID to collect feedback from our membership about restructuring RID from a member-driven organization to a professional organization

 - o We will include a poll in that email that asks members if they want to Rid to investigate the option of merging to a professional organization- Poll will close September 1st
