Outreach to Students

- Andrea, our Student MAL, has been working with Jill Radford to complete a video to encourage students to join Idaho RID-
 - o projected launch date: March or April

- We will send these out once a week so we don't spam people with too many emails

Zoom Meetings

- Dawn explained the proper steps in order to create and start a Zoom meeting with the Idaho RID account

Spring Workshop- Interpreting for Language Deprivation

- Presenters \$300/hour (\$900 for 2 days)
- We had initially planned the dates to be April 16th and 17th 10:00am-1:00pm both days
 - o Some Board members raised concerns about having a workshop on a Friday morning
 - o Jami will reach out the presenters to see if the first presenter is willing to present Friday evening or on Saturday April 10th from 10am-1:00pm instead
- Price:

 - o one day- \$35 (for .3 CEU's)
 - o both days students \$25/ 1 day for \$15
 - o non-members \$100
- We will host the Business meeting in conjunction with this workshop
 - o Fran will look in to see if we can offer CEU's for our business meeting
