INTERPotpourri In Idaho Falls

It's <u>spring</u> and time to get ready for the 'INTERPotpourri' workshop which will be held on May 18, 1974 at the Child Development Center, 2475 Leslie Avenue, Idaho Falls. Scheduled from 9:30-4:00, the workshop registration will begin at 8:30. Registration fee is \$1.00. An enclosed map will lead you to the 'INTERPotpourri' workshop sessions.

A highlight of the workshop this time will be a panel of deaf adults chaird by Dorothy Smith, IRID Treasurer. Theme for the panel is "LISTEN TO THE DEAF." Mr. Jack Downey, IRID vice-president and Suzanne Rebillet, member of the Boise deaf community will be featured panelists. Other presentations will include a class on using Manual English to interpret. A class on using the deaf idiomatic sign language in interpreting and a class on the Interpreter and Vocational Rehabilitation will round out the schedule.

Since a variety of subjects were chosen for our spring workshop, it was decided that no one theme could be found that would cover everything. Thus, our title 'INTERPotpourri' was born. If you are in doubt as to the meaning of the word potpourri, it means a miscellaneous collection...therefore, our title indicates a variety of subjects important to interpreters...but all essential to interpreter growth and development. So...c'mon and join us for IRID's third workshop and improve your skills!

The workshop will close with a brief business meeting. All state chapters of the RID have been asked to choose a delegate, other than the President, to attend the national workshop in Seattle this coming June 26-30, 1974. If you are planning to attend...and...if you are an IRID member, you are elgible to represent the Idaho chapter of the RID. If you are interested in attending as IRID's official delegate to the workshop in Seattle, please notify Jim Palmer, IRID President at the May 18 workshop. (See page 6 for map and directions)

National RID Workshop in Seattle

The National Registry of Interpreters for the Deaf will have its third workshop/convention at the Seattle Hilton, Seattle, Washington on June26-30, 1974. Five workshops have been planned for the interpreter's benefit. Workshops will include interpreter sensitivity training, legal rights of the interpreter, critique of interpreters (data has previously been sent out to the nation's deaf), instructing manual communication and interpreter training classes, and a fifth one "WORKSHOP POTPOURRI."

CONGRESS ON DEAFNESS REHABILITATION

February 15-17, 1974 was the scene of the Congress on Deafness Rehabilitation (CODR) in Tuscon, Arizona. Idaho representatives Jack Downey and Pat Young, VR state supervisor attended the meetings where a Model State Plan was presented for the development of rehabilitation services for the deaf.

National RID President Carl Kirchner says that as a result of the action taken at this Congress, key services now being performed by interpreters will be emphasized even more.

Community Interpreter Training at NTID

An eight-week course with an emphasis on training interpreters for community service will be held at the National Technical Institute for the Deaf (NTID) July 8-August 30, 1974. There is no fee or tuition for the course and required texts for the course are provided to all trainees.

Students have the opportunity to live with a deaf roommate in the NTID dorm if they so request. The RIT campus is located in suburban Rochester, New York and is easily accessible to the other areas of town.

Course description includes instruction and practicum supervised by professional interpreters, deaf adults, deaf students, and student interpreters. Concentrated instruction will be in medical, legal, educational, and reverse interpreting. Evaluation of growth in skills, related aspects of deafness, and the means to become an accepted interpreter in the community will be correlated with course instruction.

Guest speakers, national experts, as well as local professionals will be invited to address workshop participants. Extensive use of audio and videotapes as well as field experience (emergency room, deaf club, classroom, mock trial) will round out the eight-week program. The RRCD is an invaluable source of knowledge and information for anyone who needs information on deafness. Idaho interpreters should have received a letter requesting information from them about their skills and background.



RESOLUTION OF THE CENTERS AND SERVICES FOR DEAF-BLIND CHILDREN AND THE NATIONAL CENTER FOR DEAF-BLIND YOUTHS AND ADULTS ON EYE CARE FOR DEAF CHILDREN

WHEREAS vision is especially important to the education of deaf children; and WHEREAS a recent study has shown that many deaf children suffer from multiple visual difficulties; and WHEREAS records of programs serving deaf-blind adults show that a high percentage of the clientele they serve suffer from congentital deafness and retinitis pigmentosa, a condition that results in a gradual constricting of the field of vision, which can be detected in early childhood through a competent ophthalmological examination but which often, without such an examination, goes unrecognized until the constriction reaches an advanced stage in early adulthood or later: Therefore, be it RESOLVED, that the representatives of the Regional Centers for Deaf-Blind Children and the representatives of the National Center for Deaf-Blind Youths and Adults in joint meeting assembled this 23rd day of May, 1972 at the IHB Rehabilita Center in Nassau County, New York, most strongly urge all administrators of schools or other

educational programs serving deaf children to provide that all deaf children in whose education they are concerned receive thorough ophthalmological examinations as early as possible and that such examinations be repeated for all of these children annually throughout their educational careers in order that as many deaf children as possible might receive whatever surgical or medical treatment and/or corrective lenses may be required to assure that those deaf children whose vision must be expected to deteriorate will make optimum use of their residual vision and, at the same time, will not be prepared for or guided into occupations or other activities in which the use of good vision is required for success; and be it further RESOLVED that this resolution be distributed as widely as possible to educators of deaf children.

UNIVERSITY OF ARIZONA 'CENTER ON DEAFNESS'

Established in July, 1973, through a three year grant from the Arizona Department of Economic Security and the U.S. Department of Health, Education and Welfare's Social and Rehabilitation Services, the CENTER ON DEAF-NESS at the University of Arizona is actively engaged developing a community services system in the Tuscon area for deaf and hearing impaired children and adults.

As part of its work, the COD is planning a booklet on "THE DEAF PEOPLE IN ARIZONA AT WORK." It will contain photos of many deaf persons in the state at their jobs.

The COD recently arranged for the showing of a 90-minute tape on Indian Sign Language. Annette Long, COD secretary-interpreter, and Dr. Larry Stewart, COD Director, became interested in learning more about Indian Sign Language. Mrs. Long contacted Nino Cochise, who in turn, directed her to Tim McCoy, former cowboy and actor. He is considered one of the foremost authorities on Indian Sign Language. He was recently featured in a video tape, "THE SILENT LANGUAGE OF THE PLAINS," and his son who produced the film, agreed to come to Tuscon from Nogales to show it to Dr. Stewart's interpreting class and anyone else interested.
